Bidding is open to all eligible Nepalese Bidders.
2. **Gaidakot Municipality, Gaidakot, Nawalparasi, Nepal** invites sealed bids or electronic bids from eligible bidders for the construction of **Construction of Municipal Ward Building under** National Competitive Bidding Single Envelope Bidding procedures.

5. Electronic bids must be submitted to the **Gaidakot Municipality, Office of Municipal Executive, Gaidakot, Nawalparasi, Nepal** through PPMO website www.bolpatra.gov.np. on or before **12.00 noon on 2075/12/04**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders’ representatives who choose to attend at **2.00 PM on 2075/12/04**, at the **Gaidakot Municipality, Office of Municipal Executive, Gaidakot, Nawalparasi, Nepal**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRs. 241,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the specified date for last date of submission & opening falls on a government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last dates for bid submission.
8. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.
9. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
10. All other terms & conditions will be as per prevailing procurement act & regulations of government of Nepal & local body financial administrative regulation.
